- Re-assessment of the Appointment of Principal Officer

We refer to the above.

- 2. As part of Labuan FSA's continuous effort to comply with the recommendation made in the National Money Laundering & Terrorism Financing Risk Assessment (NRA), all Labuan trust companies including managed trust companies are required to appoint a Principal Officer (PO) to oversee the operations of the company. The appointment of PO will be for a period of two (2) years from the date of Labuan FSA's approval and can be renewed subject to Labuan FSA's assessment.
- 3. In this regard, all Labuan trust companies are required to identify an individual who is fit and proper to be appointed as the PO of the Labuan trust companies. The individual can also be the existing Director or Trust Officer of the Labuan trust company. Please submit the application to appoint the PO to Labuan FSA for consideration on or before 31 March 2020. The application form can be downloaded from Labuan FSA's website at www.labuanibfc.com.
