Enhancement of Labuan Financial Services Authority Statistical Management System

We wish to inform that the Labuan Financial Services Authority (Labuan FSA) is currently enhancing its statistical management system (SMS). This initiative would provide Labuan FSA with an integrated statistical management system to centrally collect statistical data via web to support the functions of Labuan FSA. The enhanced system will also remove all current manual submissions by incorporating it into the system.

2. In this regard, the SMS Enhancement Project is being implemented in three phases as follows:

- 3. For information, the project is currently in Phase 1 of the implementation stage. At this point, the system development is progressing as planned and is expected to go live on 1 January 2019. To ensure the success of the Phase 1, Labuan FSA would require the cooperation from the Reporting Entities (REs) in providing operational oversight on the coordination and arrangement of our internal initiatives. Please ensure allocation of sufficient resources to assist us to complete the Phase 1 project. The overall implementation plan of Phase 1 is attached in Appendix A.
- 4. In addition, Labuan FSA is organising a series of engagement sessions for the REs on the system implementation. The first industry briefing and user training on **Phase 1** (Niche sector only) is scheduled in November 2018. In this regard, we are inviting two representatives (a combination of preparer or checker and approver of statistical reporting) who are familiar with the current SMS submission or the person in-charge of statistical data for the engagement session. Details on the sessions and other related information on SMS enhancement project will be forwarded to REs by Industry Reporting and Management Information System Unit (IRU-MIS) in due course.
- 5. We appreciate REs full cooperation in ensuring the success of the Phase 1 project. IRU-MIS will update and notify on the development of Phase 2 and Phase 3 projects from time to time.
