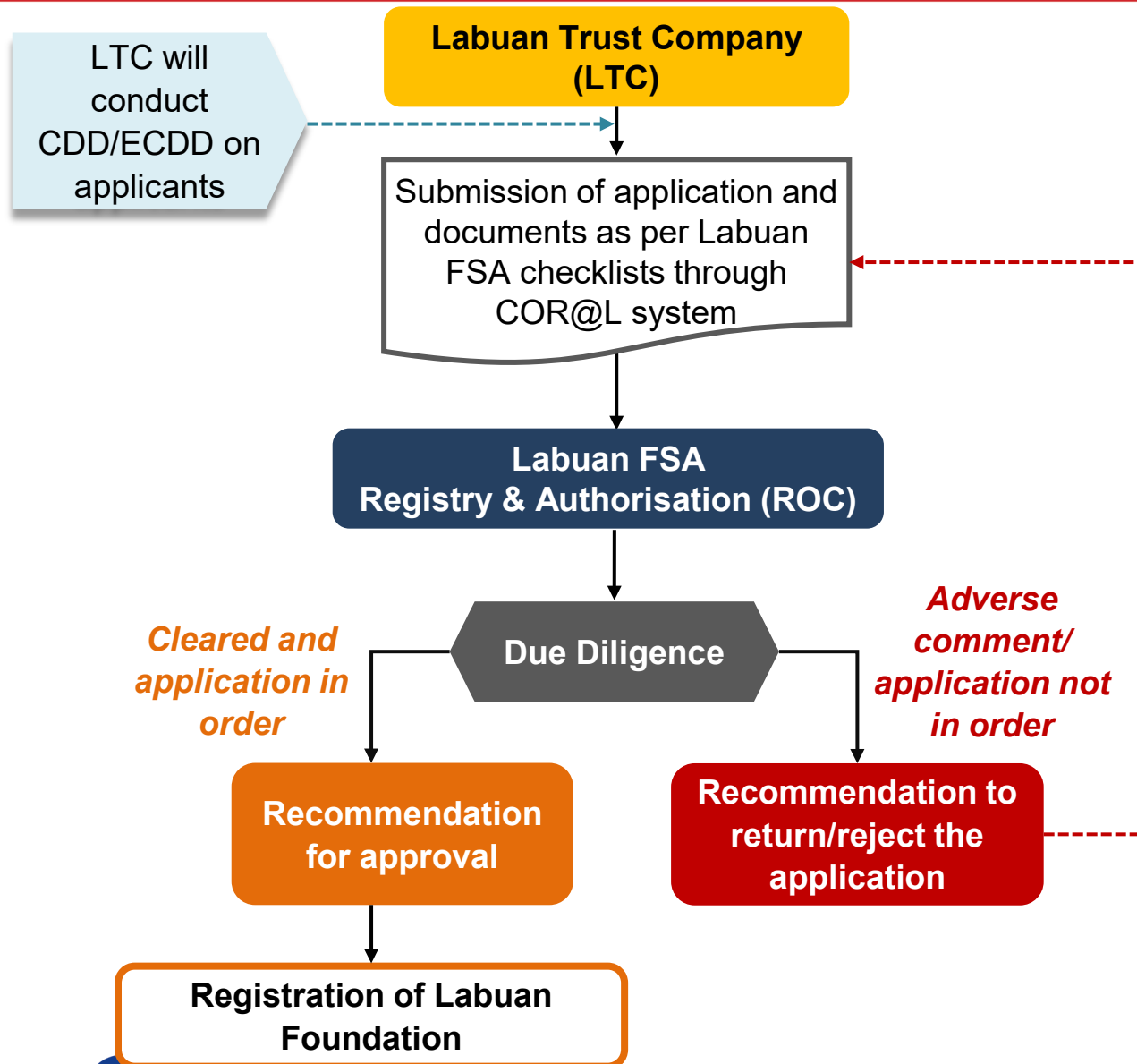

REGISTRATION OF LABUAN FOUNDATION

Application Process for Registration of Labuan Foundation through ROC



Application for registration shall be submitted by an approved Labuan Trust Company through the Labuan FSA COR@L system.

The application form shall consist, but not limited to the following information/ documents:

- Form 1 (Conventional)/ Form 8 (Islamic/Waqf): Application for registration of Labuan foundation
- Form 2 (Conventional)/ Form 9 (Islamic/Waqf): Declaration by a Labuan trust company as secretary
- Copy of the foundation's charter
- Profile of individual/ person involved in the foundation
- Statutory declarations
- Other supporting documents which applicable

Application Process for Registration of Labuan Foundation through ROC

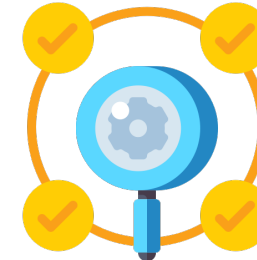
Upon receipt of application, Labuan FSA will:

1. Check the completeness of documents and information as required under S14(1) of LFA.
2. Conduct the following CDD process on the individual involved i.e. founder(s), council member(s), officer(s), supervisory person(s), shariah advisor(s) and beneficiary(ies) but not limited to:



- I. Conduct financial & security vetting
 - bankruptcy - Malaysian Department of Insolvency
 - Royal Malaysia Police Department.
- II. Conduct World-Check and KYC360⁰ screening.

ECDD checking will be performed on applications from high-risk jurisdictions or politically exposed person (PEP)



Common findings on the submission:

1. Charter provided does not comply with the Guidelines and LFA 2010
2. Inconsistent information on documents submitted
3. Incomplete application form and/or documents

Operational Requirements of Labuan Foundation

Roles and Responsibilities of the Labuan Trust Company Appointed as the Secretary to the Labuan Foundation

1. All submissions must be filed through the foundation's secretary.
 - shall within thirty days after the change, or such further period as the Authority may on application allow (S17(1) of LFA)
 - Form 4 – Notice of changes of particulars of registration of a Labuan Foundation
 - Form 8 – Notice of disqualification of a Labuan Foundation
 - Form 9 – Notice by officer/secretary of cessation of service
 - ensuring the validity, veracity, and authenticity of submissions (S43(3) of LFA)
 - maintain and timely update all records, including verifying the identity of persons on behalf of whom the founder is acting.
2. Submit bi-annual activity reports for the representative office.
3. Beneficiary ownership (BO) submission through <https://pearl.labuanfsa.gov.my>
