AKTA PERKHIDMATAN KEWANGAN 2013

PERINTAH PERKHIDMATAN KEWANGAN (INSURANS LIABILITI PRODUK DAN
INSURANS SEMULA LABUAN) (PENGECCUALIAN) 2025

PADA menjalankan kuasa yang diberikan oleh seksyen 263 Akta Perkhidmatan Kewangan 2013 [*Akta 758*], Menteri, atas syor Bank, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Perkhidmatan Kewangan (Insurans Liabiliti Produk dan Insurans Semula Labuan) (Pengeccualian) 2025**.

(2) Perintah ini mula berkuat kuasa pada 18 Februari 2025.

Tafsiran

2. Dalam Perintah ini—

“penanggung insurans Labuan” ertinya mana-mana orang yang dilesenkan untuk menjalankan perniagaan insurans am Labuan yang berhubungan dengan liabiliti produk di bawah Akta Perkhidmatan Kewangan dan Sekuriti Labuan 2010 [*Akta 704*];

“penanggung insurans semula Labuan” ertinya mana-mana orang yang dilesenkan untuk menjalankan perniagaan insurans semula Labuan, atau retrosisen di bawah Akta Perkhidmatan Kewangan dan Sekuriti Labuan 2010.

Pengeccualian

3. Menteri mengeccualikan—

(a) penanggung insurans Labuan daripada pemakaian perenggan 8(1)(a) Akta yang menghendaki penanggung insurans Labuan itu untuk mendapatkan suatu lesen untuk menjalankan perniagaan insurans am;

- (b) penanggung insurans semula Labuan daripada pemakaian perenggan 8(1)(a) Akta yang menghendaki penanggung insurans semula Labuan itu untuk mendapatkan suatu lesen untuk menjalankan perniagaan insurans semula; atau
- (c) mana-mana orang yang membuat atau menyebabkan untuk dibuat suatu kontrak insurans am yang berkenaan dengan liabiliti produk dengan seorang penanggung insurans Labuan daripada pemakaian subseksyen 127(1) Akta yang menghendaki orang itu untuk mendapatkan kelulusan bertulis terdahulu Bank bagi tujuan tersebut.

FINANCIAL SERVICES ACT 2013

FINANCIAL SERVICES (LABUAN PRODUCT LIABILITY INSURANCE AND REINSURANCE)
(EXEMPTION) ORDER 2025

IN exercise of the powers conferred by section 263 of the Financial Services Act 2013 [Act 758], the Minister, on the recommendation of the Bank, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Financial Services (Labuan Product Liability Insurance and Reinsurance) (Exemption) Order 2025**.

(2) This Order comes into operation on 18 February 2025.

Interpretation

2. In this Order—

“Labuan insurer” means any person licensed to carry on Labuan general insurance business relating to product liability under the Labuan Financial Services and Securities Act 2010 [Act 704];

“Labuan reinsurer” means any person licensed to carry on Labuan reinsurance business, or retrocession under the Labuan Financial Services and Securities Act 2010.

Exemption

3. The Minister exempts—

(a) a Labuan insurer from the application of paragraph 8(1)(a) of the Act which requires such Labuan insurer to obtain a licence to carry on general insurance business;

(b) a Labuan reinsurer from the application of paragraph 8(1)(a) of the Act which requires such Labuan reinsurer to obtain a licence to carry on reinsurance business; or

- (c) any person who enters into or causes to be entered into a contract of general insurance with a Labuan insurer in respect of product liability insurance from the application of subsection 127(1) of the Act which requires such person to obtain prior written approval of the Bank for such purpose.
